ORDINANCE NO. 26

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF BERRYSBURG, DAUPHIN COUNTY, PENNSYLVANIA, ACCEPTING THE OPENED STREET OR ROAD KNOWN AS LYKENS STREET.

TO THE CLERK OF THE COURT OF COMMON PLEAS, DAUPHIN COUNTY:

WHEREAS, LARRY E. LETTICH AND DOROTHY V. LETTICH, HIS WIFE, HAVE OFFERED, DEDICATED, RELEASED, AND QUIT CLAIMED UNTO THE BOROUGH OF BERRYSBURG, DAUPHIN COUNTY, PENNSYLVANIA, CERTAIN LANDS TO BE USED AS A PUBLIC STREET OR ROAD; AND

WHEREAS, THE BOROUGH COUNCIL FOR BERRYSBURG BOROUGH, DAUPHIN COUNTY, PENNSYLVANIA, IS DESIROUS OF ACCEPTING SAID LAND AS A PUBLIC STREET OR ROAD.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED, AND IT IS HEREBY ENACTED AND ORDAINED BY THE COUNCIL OF THIS BOROUGH PURSUANT TO §1731 OF "THE BOROUGH CODE", AS FOLLOWS:

THE BOROUGH DOES HEREBY APPROVE AND ACCEPT THE OPENED STREET OR ROAD KNOWN AS LYKENS STREET WITH THE SAME TO BECOME A PART OF THE PUBLIC ROAD SYSTEM OF BERRYSBURG BOROUGH, DAUPHIN COUNTY, PENNSYLVANIA, WITH THE SAME BEING DESCRIBED AS FOLLOWS, TO WIT:

Beginning at a point in the middle of the intersection of South Second Street and Lykens Street; thence South two degrees thirty minutes East for a total distance of 5 + 28.16 feet to a point in the middle of a turnaround, with the said Avenue to have an overall width of thirty-three (33) feet and a turnaround with a radius of forty (40) feet at the southern end of said Avenue.

IT IS FURTHER ENACTED AND ORDAINED THAT THE SURVEY AS MADE BY K. I. DANIEL, REGISTERED PROFESSIONAL ENGINEER, DATED MAY 16, 1974, SHALL BE THE OFFICIAL SURVEY FOR THE AFORESAID AVENUE.
