### ORDINANCE NO. 30

AN ORDINANCE OF THE BOROUGH OF BERRYSBURG, COUNTY OF DAUPHIN, AND THE COMMONWEALTH OF PENNSYLVANIA, RATIFYING A C.A.T.V. FRANCHISE GRANTED TO LYKENS TV CO., INC., TO OPERATE AND MAINTAIN A CABLE TV SYSTEM IN THE BOROUGH OF BERRYSBURG, AND AUTHORIZING THE ASSIGNMENT OF SAID FRANCHISE TO CENTURY LYKENS CABLE CORP. "

PURSUANT to the Act of February 1, 1966, P.L. (1965) \_\_\_\_\_, No. 581, as amended, 53 P.S. §46202, the Borough Council finds:

1. LYKENS TV COMPANY, INC., is operating a C.A.T.V. system in the Borough of Berrysburg pursuant to a franchise awarded to it by the Borough Council of Berrysburg Borough, effective July 3, 1979 and amended on June 7, 1982; and,

2. Said franchise was awarded pursuant to an agreement entered into between the Berrysburg Borough Council and Lykens TV Company, Inc., said agreement having been authorized by Resolution of the Berrysburg Borough Council on August 24, 1979; and,

3. LYKENS TV COMPANY, INC., has entered into an agreement to sell its assets to Century Lykens Cable Corp. and has notified the Borough Council of said agreement; and,

4. CENTURY LYKENS CABLE CORP. has notified the Borough Council of its desire to operate the Borough of Berrysburg C.A.T.V. franchise pursuant to the terms and conditions of the franchise granted to Lykens TV Company, Inc.; and,

5. The Berrysburg Borough Council has reviewed and is satisfied with the qualifications of Century Lykens Cable Corp.

BE IT AND IT IS HEREBY ENACTED AND ORDAINED,  
AS FOLLOWS:

1. The Berrysburg Borough Council hereby ratifies and adopts the franchise resolution dated August 24, 1979, and franchise agreement, entered into pursuant thereto, dated July 3, 1979 and attached hereto, and the June 7, 1982 amendment to said franchise agreement, granting a C.A.T.V. franchise to operate and maintain a cable TV system in the Borough of Berrysburg to Lykens TV Company, Inc., setting forth the terms and conditions accompanying the franchise, and providing for the regulation of C.A.T.V. system.

2. The Borough Council hereby approves the assignment by Lykens TV Company, Inc., to Century Lykens Cable Corp. of said franchise together with all of the rights, privileges, duties and obligations granted to Lykens TV Company, Inc., in accordance with this Ordinance, and franchise resolution and agreement enacted on August 24, 1979 and agreement amendment dated June 7, 1982 and ratified herein.
