ORDINANCE OF  
BERRYSBURG BOROUGH  
DAUPHIN COUNTY, PENNSYLVANIA

An ordinance of Berrysburg Borough, Dauphin County, Pennsylvania, providing for compensation for the Borough Councilman, President of Borough Council, Mayor, Secretary, Treasurer and Auditors, pursuant to the authority of the Borough Code of Pennsylvania 53 P.S. §46001, 46006 and 46024 providing severability clause and providing an affective date.

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF BERRYSBURG BOROUGH as follows:

§1. Short Title. This ordinance shall be known as the "Municipal Officers Compensation Ordinance of Berrysburg Borough.

§2. Authority. The Borough Code of Pennsylvania provides for payment of compensation to members of Borough Council, Mayor and elected and appointed officials of the borough as found in 53 P.S. §46001, 46006 and 46024, all as amended.

§3. (a) Compensation for Councilman shall be at the rate of \$25.00 per meeting and \$25.00 for any special meetings attended by members of Council.

(b) Compensation of the President of Borough Council shall be \$400.00 per annum, and in addition, \$25.00 for any special meetings attended by the President of Borough Council.

(c) Compensation of the Mayor of Berrysburg Borough shall be \$400.00 per annum, and in addition, \$25.00 for any special meetings attended by the Mayor of Berrysburg Borough.

(d) Compensation of the Secretary of the Borough Council shall be \$1,200.00 per annum, and in addition, \$25.00 for any special meetings attended by the Borough Secretary.

(e) Compensation of the Treasurer of the Borough Council shall be \$500.00 per annum, and in addition, \$25.00 for any special meetings attended by the Borough Treasurer.

(f) Compensation of the Auditors of the Borough Council shall be \$25.00 per meeting of Auditors.

§4. Should any section, subsection, sentence, clause or phrase of this ordinance be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of the ordinance in its entirety or of any part thereof other than that declared to be invalid.

§5. This ordinance shall be retroactive to January 1, 1990.
