**Appointment of Gregory A. Mowery to the Office of Borough Code and Ordinance Enforcement Officer for the Borough of Berrysburg.**

**Whereas**, the Borough of Berrysburg has duly enacted ordinances and may enact additional ordinances and or borough codes in the future which provide for but are not limited to the protection of borough residents from nuisances and or provide for the protection of the borough residents' health, safety, morals, general welfare, and or provide for the protection, conservation, and or the preservation of all property and or the natural environment and resources within the borough whether publicly, privately, or borough owned and or provide for the maintaining of civil order within the borough, and

**Whereas**, these duly enacted ordinances and any such future enacted ordinances or codes of the Borough of Berrysburg provide for and or will provide for the enforcement of the same through the issuance of citations levying fines and enforcement costs for violations thereof, and

**Whereas**, the Berrysburg Borough Council has the legal authority as provided by *The Borough Code of the Commonwealth of Pennsylvania, Act of 1966 As Amended* and by the authority provided by the Berrysburg Borough Ordinance #44 *Code and Ordinance Enforcement* ordinance and has an obligation to the borough residents to provide for all means necessary for the legal enforcement of these said enacted ordinances and or any and all future enacted ordinances or codes by the official appointment and empowerment of a Borough Code and Ordinance Enforcement Officer and to empower said Officer in accordance with said Borough Ordinance #44 with the authority to issue citations for code or ordinance violations at the behest of and upon the receipt of a Directive to Issue a Citation from the Borough Code and Ordinance Enforcement Administration.

**Now, Therefore be it Resolved** by the Berrysburg Borough Council in accordance with Borough Ordinance #44 and effective immediately upon the adoption of this Resolution; that Gregory A. Mowery while under contract for the Borough is hereby appointed to the Office of Borough Code and Ordinance Enforcement Officer for the Borough of Berrysburg, and

**Be it further resolved** in accordance with Borough Ordinance #44 and effective immediately upon the adoption of this Resolution; that Gregory A. Mowery said Borough Code and Ordinance Enforcement Officer upon receipt of a Directive to Issue a Citation from the Borough Code and Ordinance Enforcement Administration is hereby officially authorized and empowered to issue said citations for ordinance and or code violations at the behest of the Berrysburg Borough Code and Ordinance Enforcement Administration.
